No additions or corrections.


**Voting on Motion:** All yeas, no nays – **Motion Passed**

The Police Department is also changing their hiring practices and they will be testing with nine other agencies, but there is no further testing till spring.
- **Attorney:** Kevin Kaufhold asked for an Executive Session, on personnel issues.
- **Superintendent of Public Works:** Brian Rader informed the board the Village has been busy dealing with many water breaks, because of the heat. Brian Rader also informed the board that the St. Clair County Park Grants Applications were out. Brian spoke that the CSX Railroad has been informed of the condition of the tracks that run through the Village. Brian also informed the board SCI did report that the huge problems was with the drainage and mine subsidize. AT & T still have not been out to move the lines.
