- At the Caseyville Fire Department event, we did handle fingerprinting I.D. for our youths and there was also a K-9 demonstration, all went well
- In the process of testing for two (2) police sergeants
- We have our new vehicles back from the shop, and they will be on the streets soon

Attorney: Kevin Kaufhold

- Still working on the on the Sex Predator Ordinance and hopefully will have it by next board meeting
- Also looking to purchase three (3) properties that have been abandoned or vacant. Some properties are up for back taxes and we can purchase them for minimal value. The former attorney delivered a box to my office with more demolitions from earlier and we will go through those also. It takes a lot of procedures to demo these houses. Moving as quickly as we can right now.

Superintendent of Public Works

- Grant for \$8100 came in working with Chief on new tasers and speed limit radar sign
- Park grant for \$46,000, that will allow us to put out bids for two (2) commercial mowers
- Working on \$80,000 grant for water main replacement and upgrade on Sterling
