RESOLUTION#

RESOLUTION APPOINTING BRENDA WILLIAMS PRESIDENT PRO TEM

WHEREAS, the Village Board of the Village of Caseyville, St. Clair County, Illinois, has determined that it is in the best interest of the Village to ensure continuity in the discharge of the duties of the Office of Mayor, and,

WHEREAS, Section 3.1-35-35 of the Illinois Municipal Code provides that, in the event the Mayor is temporarily absent because of an incapacity to perform his official duties, the Village Board must elect one of its members to act as mayor pro tem; and,

WHEREAS, the Village Board has determined that the mayor will be temporarily absent and unable to perform his official duties, but that a vacancy has not been created in the office; and,

NOW, THEREFORE, be it resolved by the Board of Trustees of the Village of Caseyville, St. Clair County, Illinois as follows:

SECTION 1. The recitals set forth above are true and correct and incorporated herein as if fully set forth herein.

SECTION 2. The Village Board has elected Trustee Brenda Williams to serve as Mayor Pro Tem in the temporary absence of the Mayor.

SECTION 3. Pursuant to 65 ILCS 5/3.1-35-35 Trustee Brenda Williams shall perform the duties and possess all the rights and powers of the mayor, but shall not be entitled to vote both as mayor pro tem and as trustee.
